215/12: TO RECEIVE APOLOGIES FOR ABSENCE

216/12: TO RECEIVE ANY DECLARATIONS OF INTEREST

Cllr R Filmer declared a prejudicial interest on all planning matters due to his position on the District Planning Authority. Plus pecuniary declarations of interest by Cllr Hurkett, Cllr Ward, CllrTrivett-Bill and Cllr Filmer as trustees of the Parish Hall (in consideration of grants) Cllr J Harper as a member of PCC and declared pecuniary interest on the St Michaels church grant. Cllr I Ward pecuniary interest on the application of meet and eat grant discussions

217/12: The minutes from the meetings on 5th and 19th November 2012 were approved and accepted as true accounts of the meetings

ONGOING ISSUES

218/12: Footpaths: A stile collapse was reported at the top of Manor Ride and a walking of the village stiles was agreed by members of the Parish Council to ascertain the extent of the stile maintenance needed in and around the village.

Many footpaths have become very wet during the recent bad weather and more will be considered as part of the overall flood planning strategy.

Action Points:

Cllr Knott and Cllr Harper will walk around the village and Consider the issues of the stile maintenance.

219/12: Highways: Church Lane opposite Bodys Lane is in a bad condition currently and also the road outside the bungalow at the end of Manor Ride is in need of some reconstruction work. It was reported that the white lining outside of Tadpoles in Brent Street has now been completed.

Action Points

Follow up identified further in these minutes with the Parish Council strategy for dealing with recent flood issues.

220/12: Village Green: Much of the green has been underwater over the past month there are significant concerns regarding blocked culverts and Rhynes. The rear fence is still waiting for repair and there are some hedges that still need to be trimmed The overgrown bushes close to the Parish Hall border require severe cutting back. It was resolved that this matter will now be dealt with and estimates to be given to deal with the matter will be sought.

Action Points:

Cllr Osborn to deal with fencing repair and estimates sought to Clear the overgrown hedges and scrub near the Parish Hall Clerk

with Chris East and request a visit to look at all of the options available before committing to this capital expenditure.

236/12: Flood and Drainage issues in and around the village:

The meeting heard from a number of local residents prior to the meeting regarding the recent problems in an around the village as a result of bad weather. The Parish Council are determined to deal with this matter in the best way that it can in the coming months.

237/12: Water Channelling from the Knoll footpath Rhynes over filling in various locations Flooded homes in Brent Knoll Sewer problems and over flows

Surface Water issues over loading

238/12: As a result of the discussions that took place decisions have been taken by the Parish Council.

239/12: To set up as a matter of urgency and no later than January a multi agency meeting in the village to include the following agencies

Somerset County Council Brue / Axe Drainage board Bristol Wessex Water Parish Council Environment agency

240/12: Survey of local rhynes ditches and residents experiences this will be added to the communication survey already planned for January edition of BKN.

241/12: An article will be placed in BKN Requesting that residents do themselves look at their surrounding ditches and rhynes to ensure that they are clear of obstructions.

242/12: A management plan by the Parish Council to deal with issues in the future and also to consider any contingency policy this should be put in place early in the New Year.

243/12: The above action plan will be aimed at supporting the village during the difficult periods of flood risk and to determine from the main agencies their action plans for 2013

244/12: Community Warden Scheme:

This scheme has been set up with funding to allow groups of Parishes to have the services of a community warden with a time allowed of 5 years. It will be necessary for one of the Parish Councils to take a lead and Brent Knoll have offered this support for the Scheme and more on this matter will be forthcoming in 2013. There is also a community enablement fund which will be used to fund specific projects in the villages.

245/12: Use of Village green for Fete and Music events in 2013

At this point Cllr R Filmer, Cllr A Hurkett, Cllr C Trivett Bill and Cllr I Ward left the meeting having declared a pecuniary interest as trustees of the Parish Hall.
