<u>Sedgemoor CAB:</u> It was resolved to make a grant of £ 100.00 to this local organisation.

Brent Knoll Primary School: It was resolved to make a grant in the sum of £250.00 towards the purchase of a Lap Top computer

St Michaels PCC: A request has been received to support remedial work to the roof of the church together with additional handrails for the stairway to the ringing chamber and clock face repairs. The Parish Council decided in principle that they would make a small grant for the roof repairs but not the other two matters. It was resolved however to requests more information on the progress of the fundraising and the total costs involved in the roof project prior to deciding to make a final grant offer.

PLANNING CONSIDERATIONS

335/14: 07/14/00022: (Tree Preservation Order) regulations 1969 At Greystones Burton Row Brent Knoll TA9 4PB. The Parish Council supported this proposal on the grounds of good arboreal practice

336/14: 31/14/00024: Certificate of lawfulness for the existing use of land to site one static caravan on land at 0S Field no 7229 Brean Road Lympsham The Parish Council made no observations to this proposal.

337/14: 07/14/00016: Erection of replacement dwelling and demolition of existing dwelling at Pink Cottage Burton Row Brent Knoll TA9 4BX. The Parish Council supported the proposal on the grounds the revised application now on existing footprint together with the garage also on existing and supporting the improvement to the landscape.

338/14: 07/14/00023: Erection of single storey dwelling and replacement garage, alterations to access, demolition of existing garage. At the Orchard

Burton Row, Brent Knoll TA9 4BX. The Parish Council objected to his proposal on the grounds of loss of light to neighbouring properties and causing over shadowing also loss of privacy to adjoining property. There also potential landscaping flooding issues and traffic safety issues with the entrance to the property.

MATTERS OF CONSIDERATION

339/14: Affordable Housing:

The Parish Council were updated earlier in the day from the affordable housing team at Sedgemoor. A number of issues were raised in connection with types of property and site locations all of which require further discussion. It was therefore resolved to defer matters until the January meeting.

340/14: CPR Training:

Following on from previous discussions it has been decided to accept the offer made by St John's Ambulance service to run CPR Training sessions in March for 24 people and to publicise this activity within the village. It has been resolved to write to the Nuttall Trust to outline our proposals and to request that we use their recent grant to support this training function.

341/14: Speed Indicator installation protocols

The matter has been taken up with Cllr H Siggs and will hopefully be resolved early in the New Year

342/14: Jungle West Road

The bridal path at this location has a history of requiring attention which is shared between 3 Parish Councils. Brent Knoll has resolved to get some quotations work early in 2015. Cllr D Knott will make some enquires on the matter for quotes to be sought

343/14: The Beat Surgery Future

There is conflicting information regarding the plans for 2015 to reduce Beat Surgeries in the area. The clerk will try to ascertain more information at the December surgery on the 3rd December.

344/14: Coastal Cluster meeting in November

Matters appertaining to Bus routes, Mobile Libraries and Broadband were discussed the former subjects below.

345/14: Bus Route 102 Signature of Chairman

An online survey is available and letters direct to SCC Will support these surveys for the retention of this valued service from the village.
