#### **UDDATING REPORT BY VILLAGE AGENT KIM WILCOX**

**269/15:** Our Village agent gave the Parish Council an up to date briefing on her work as part of team of Village Agents in The Somerset area.

Key Points from the presentation

- 1. Now working with Medical centre in East Brent
- 2. Clinical Commissioning funding to expand Medical centres expansion
- 3. Village agent now operating 24 Hours a week
- 4. There are now 10 agents in the County

- 5. Half of Somerset now covered by agents
- 6. Kim Wilcox has 52 Clients
- 7. 21 Clusters in the County of Somerset

283/15: Consideration of budget and precept for 2016/17

The mini finance group met earlier in the day for a detailed look at the budget proposal by category. The Clerk highlighted the budget on the overhead to enable all members and public to see clearly the workings on the Budget. There were minor changes of the proposed budget and consideration given to the level of reserves for the Council going forward and it was decided that a figure of 9 months expenditure should be set as the Council reserves figure.

**284/15:** A precept level for the year **2016/17** was set at a figure £29,672.00 this reflects the Councils commitment to spending on the ongoing Culvert Work and some additional spending on IT Projects and Extension of the village maintenance contract and Churchyard contract.

#### 285/15: SID Progress

It was requested that we should consider offering support to the sterling work being undertaken by Richard Ibrahim. The Parish Council are also considering advertising for small jobs person on a self employed basis as and when required who could also double to assist with SID.

## 286/15: County Council Funding

It has been suggested that Fitness Courses being run locally may be acceptable for this funding and the Village Agent is investigating opportunities that may exist

#### 287/15: Problems in East Ride

Cllr J Harper and C Trivett – Bill left the meeting having declared and interest For some time residents in East Ride have been concerned about Noise pollution and Animal welfare issues in the Close. This matter is not an issue that the Parish Council have any authority to deal with however Sedgemoor District Council have forwarded a letter to Cllr Filmer in which it states that efforts have been made to install monitoring equipment to assess the noise pollution but have failed to get any agreement from local residents in East Ride.

## 288/15: Broad band Provision in Brent Knoll

The fibre Optic service is now available in the village and is now an option being taken up by residents in the village.
