#### 346/15: Play Equipment future upgrading

A Further look at the whole area of the play area to be considered by a working group who will consider the most important aspects of any improvements and then the Council to consider the costing and funding sources. This will be an ongoing matter over the spring and summer 2016

## 347/15: The recycling areas next to the toilet block

Some outline drawings presented to the Council for possible future extension of the car parking areas and to remove the existing fence barrier between the car park and the toilet block to be further discussed in April

## 348/15: Hadstone Energy Community Grant

The Parish Council have received a 5k grant for any proposed community project decided upon by the Parish Council this has been accepted by the Parish Council

## Some ideas so far include

Money to support any improvements to the Fox and Goose Junction Church Roof Project Bus Shelters Brent Corner end of the village

Others will be further put forward at a future meeting

#### 349/15: Wessex Water Infrastructure Project

Correspondence from Wessex Water on the proposed improvement project for the village suggest that they are on target for work starting later this year. The Parish Council will try to ascertain the level of disruption that may be caused to the village for this vital work.

## 350/15: Annual Meeting Agenda resolution

An agreed format for the forthcoming APM was considered to facilitate both the presentation by the rev Simon Lewis and the Wessex Water updating process.

## 351/15: Horse gate Installation in Crooked Lane

It is hoped that an installation of this gate will take place within two weeks.

## 352/15: The reservoir footpath surround

It has been agreed with Bristol Water that having cleared the path overgrowth recently that a maintenance contract to be carried out regularly by the board should be instigated and that has been agreed.

#### 353/15: No Right Turn from the Wyevale garden Centre

Some concern raised at the previous meeting about the poor condition of the far side no right turn signage on exit from the garden centre. The County have been contacted and have denied liability for that sign. However it is on the highway and the Council are of the view that something may have been agreed during the original planning process. Cllr Filmer has agreed to investigate this matter with the planning authority.

#### 354/15: Filming of meetings

A question was raised about the placing of meetings on "You Tube". It was stated that this is now part of any filming protocols allowed under recent legislation and the process is in line with current rules and legislation. Any member of the public can film a meeting provided that the protocol is adhered to.

## 355/15: Handy Man appointment for the Village

The matter will be considered and a specification for a self employed person to carry out some of the regular maintenance. Some jobs often fall to the members and this seems at times unworkable. A specification will be brought before the next meting and to consider the financial aspects.

## 356/15: Litter Clean for Queens 90th Birthday celebrations in 2016

It was agreed to place an article in the BKN to request volunteers from the village to assist with a cleanup prior to the celebrations this year.

## 357/15: Flyers on telegraph poles after events have completed

It has been noted that flyers advertising local events tend to remain long after the event and it was resolved to place an article in the BKN. Requesting the removal of such flyers.

#### 358/15: Queens's 90th birthday celebrations 2016
